The pipe organ was built and installed in 1864 by E.& G.G. Hook of Boston, as their opus 342. It was featured last year at the national convention of the Organ Historical Society; it has not been altered, except for the addition of an electric blower.

Mr. Matthew, organist at St. Stephen's Episcopal Church in Middlebury, Vermont, is well-known both as organist and as carillonneur. His programs include outstanding compositions that are not as well known, as well as standard works in the organ repertoire.

You are also invited to the last recital in this year-long celebration, to be given by Susan Summerfield (with special guests) on Sunday, November 2, at 4:00 p.m.

Sunday, September 14 at the Church of Christ at Dartmouth College (the White Church) international organ recitalist Susan Ferre returns to Hanover to play a program of Bach and French organ music. Her last recital here was standing-room only so mark your calendar now and plan to bring a friend. These concerts are free and were established in memory of Mary Ives.
