OCTOBER VERMONT AGO EVENT IS AN ORGAN TOUR IN CHESTER, VERMONT ON OCTOBER 9

The Chapter's fall organ tour on Sunday, October 9 will be in the charming village of Chester boasting lots of Victorian architecture and three pipe organs. We will start at the red brick First Baptist Church at 3:00 p.m. and hear the Estey Organ Company instrument of two manuals built for this church in 1927. Phil Stimmel will play the program, and the church's organist Christian Thayer will open with a hymn.

We will then walk to St. Luke's Episcopal Church on the opposite side of the street, where, at 3:45 p.m. Peter Walker will play the 1870 one-manual S. S. Hamill organ with the church's organist Ashley Paine opening with a hymn.

Lastly, we will cross the street again and visit the white meetinghouse Congregational Church at 4:30 p.m. where Lynnette Combs will play the 1898 two-manual S. S. Hamill organ. The church's organist Lorri Bond will open with a hymn.

East Cambridge, Massachusetts organbuilder Samuel S. Hamill built upward of a dozen instruments in the Chester area, five of which are extant.

Refreshments will follow this program.

For those who prefer not to walk, there is ample parking at each church.

The schedule is as follows --First Baptist Church 3:00 to 3:30 St. Luke's Episcopal Church 3:45 to 4:15 Congregational Church 4:30 to 5:00

DIRECTIONS: From the east, take Exit 7 off Interstate 91 and follow Route 11 through Springfield to Chester. First Baptist Church, our first stop, is on the right side of the main street. From the west take Route 11 to Chester, pass the white Congregational Church on the left and gray St. Luke's Episcopal Church on the right and stop at the red brick First Baptist Church on the left.

COMING EVENTS

An organ tour of the three pipe organs in Chelsea, Vermont will be on Sunday, October 9. More details are outlined on the first page of this newsletter.

The 15th recital in the Katharine E. Dopp organ recital series will be held at First Baptist Church, St. Paul St., Burlington, on Sunday, Nov. 6 at 3:30 p.m. The artist is Kola Owolabi, Associate Professor of Organ at the University of Michigan, Ann Arbor. Kola played the 1864 E. & G.G. Hook (Op. 342) a few years ago, when the Organ Historical Society visited northern Vermont. The recital is free, but all donations help support the series. Refreshments will be served. There are 3 parking garages and street parking in close proximity. Handicapped accessible.

On Friday, November 11 at 7:30 p.m. at The Cathedral of St. Paul at 2 Cherry Street in Burlington, Vermont a program entitled Latitude with Attitude: Organ Works from Around the 52nd Parallel will be offered by Gayle Martin, organist. "Latitude with Attitude" features composers hailing from the 52nd parallel in Canada and Northern Germany. Works by Sweelinck, Buxtehude, Lubeck, and Bach represent the early-,mid-, and high-Baroque periods, with this early music portion of the program culminating in a concerto by J.S. Bach. The progression of compositional traits displays how these composers learned from one another. The program also includes vibrant works of modern Canadian composers Willan, Kloppers, and Bedard. Admission: \$20; Students 15-22 and Seniors \$15; Children 14 and under: Give what you can.

It was a clear, breezy early Fall day as people gathered at the United Church in West Rutland on Sunday, September 11 to hear the 150-year-old Wm. A. Johnson organ on the occasion of its birthday celebration. Vaughn Watson, Jim Cassarino, and John Riddle played a wide variety of music, and it all sounded glorious despite the narrow, offset 20-note pedalboard! Jim Cassarino made a point of playing American music of the mid-19th century, confessing that, although it wasn't very good, it would have been heard on that organ at the time it was built. The appeciative audience of almost 100 then enjoyed the elegant refreshments put out by the women of the church.
