# Update on the Tax Exempt Status of the Vermont Chapter

The Headquarters of the American Guild of Organists (AGOHQ), is becoming more alert to issues that concern our Federal Government. Various Chapters have found themselves in the state of having to reinstate their tax exempt status retroactively. Although it is specified in our Chapter Guidelines documentation that Chapters have to file a Form 990-N every year, many Chapters have failed to do so and unfortunately, our Chapter has failed to file for 3 consecutive years.

The consequence of failure to file the 990-N for 3 consecutive years is automatic revocation of our tax exempt status. Fortunately for our Chapter our tax-exempt status was revoked in May of this year 2016 and this allows us to file a much shorter form to have our tax exempt status retroactively reinstated. As an aside, the shorter form 1023-EZ is multiple pages shorter than the 1023.

We wish to thank Celia Asbell for offering her CPA services pro bono. She responded promptly to our group email and has helped Esther wade through all the pertinent documentation. Eric Birk from AGOHQ has also been very helpful. Thank you, Celia, and thank you, Eric.

We filed the 1023-EZ on November 17th 2016 electronically as this is the only was for the form to be submitted. Since November 15 of every year is the deadline for the 990-N submissions it might take a while before we learn of our reinstatement. We anticipate some correction of entries on our 1023-EZ but hope that all will end well and that we can report to our members that our tax exempt status has been reinstated retroactively.
